What do I need to know before buying?

- **US dollar → Canadian dollar**
 - a. Find a broker here: [XE](#)
 - b. Use a flooring line: [AFC](#) OR NEXT [GEAR](#)
- **Duty**
 - For duty free purchases you need to purchase duty free vehicles. Duty free vehicles are vin's that begin with the numbers: 1,4 or 5. Vehicles that have duty start with the numbers: 2, 3 OR a letter. Trucks are dutiable by 25%, while ANY other passenger car or MPV is only dutiable by 2.5%. This is **critical** to understand.
- **Appendix A and B**
 - Vehicles listed on Appendix [A](#) and [B](#) are NOT eligible for import, unless you can provide a letter from the OEM stating that the TPMS was installed.
- **No fix recalls**
 - Vehicles with active no fix recalls (no remedy available) are not eligible for import unless a deal-ership can provide an ETA on a remedy. If we are not able to complete a recall within 120 days from the arrival of the vehicle, the vehicle will have to be exported.

 - Private dealers, franchised stores, or other online private consumer platforms.

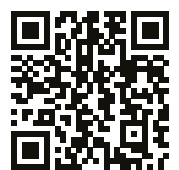
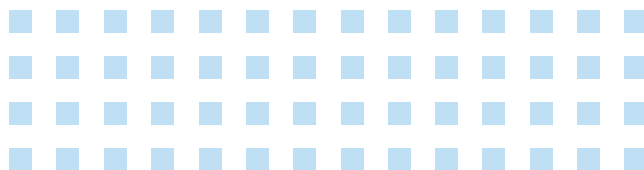
What about my taxes?

- You do need to have a GST/HST # to purchase vehicles at auction in Canada
 - **Alliance offers a service to set this up for 1599.99**The auctions require 5 percent at the time of purchase, but this is refundable with GST Refund Submission

What do I do after I purchase?

- **Set up transportation**
 - Set up transportation to an Alliance Imports holding lot
- Alliance offers a dispatching service of 50 per unit
- **Importation documents**
 - Send all vehicle information to Alliance Imports via email to set up importation documents

What happens once my vehicles arrive?

- **30 day hold**
 - All vehicle imports must sit for 30 calendar days after arrival. This is in accordance with the federal law. During this time we inspect units, convert units to US standards, clear recalls, prepare title documentation, and recondition units. Your vehicle will be releasable on the 31st day after arrival.

After my vehicles release, am I ready to sell?

- **YES!**
